# ADDENDUM STAFF REPORT PP 226 22

# **Brampton Brick Limited**

14504 Mississauga Road

Part Lots 29 and 30, Concession 5 West of Centre Road (Former Township of Chinguacousy), Town of Caledon, Region of Peel

#### **BACKGROUND:**

On January 18, 2024, Staff brought forward a summary report recommending that the Commission recommend to the Minister that the amendment **not** be approved because the proposal is not consistent with the Niagara Escarpment Plan (NEP). Staff demonstrated that the lands are properly designated EPA. The plan does not allow for consideration of MREA on lands designated EPA. The approved motion was to defer a decision on recommendation to the Minister pending consideration of a proposal by the applicant which the Commission has ability to consider, and which will address the goals of the Commission and the community linking phase 3 and phase 4 (the new lands). The Commission asked Brampton Brick to consider options that would assure surrender of the Phase 3 lands, and then to return to the Commission for further consideration and a final recommendation to the Minister.

Brampton Brick, their consultants and solicitor had several conversations with NEC staff and the Legal Services Branch solicitor about potential options between January 2024 and February 2025. The outcome of the discussions resulted in a proposed approach to enter into a legal undertaking through which Brampton Brick will commit to surrendering phase three lands subject to the issuance of a license on the new phase 4 lands. During these discussions, MNR aggregate staff were consulted on how an application for the new license on the phase 4 lands could be reviewed at the same time as an application to surrender phase 3 lands, and they have confirmed that this could be considered.

#### **CONCLUSION:**

NEC staff have not changed their planning advice to the Commission regarding the proposed plan amendment as the NEP does not allow for consideration of MREA on lands designated EPA.

Staff advise that the draft legal undertaking appears to sufficiently address the Commission's January 18, 2024, direction to ensure the Phase 3 lands could never be extracted should the proposed Plan Amendment be approved by the Minister and the phase 4 lands eventually licensed.
